# 3. Conference Update

Patrice updating.

- Friday 25<sup>th</sup> November– will be the conference.
- Registrations started
- Meeting with Te Papa finalised large room which holds 100 people. To consider if we hold a refresher day on the Thursday before Conference.
- Action: Patrice and Indra to make sure the date is on the website and for people to indicate if they are interested.
- Abstracts being provided including -Cultural Competencies; Finishing Therapy; 'Secret keeper', sculptures and book on Journey of dissociation; case presentation; and possible presentation with child theme and one on bi polar

## 4. Pathway Group - Eligibility to train in EMDR.

Diane updated us on the groups meeting, acknowledging Tom Flewett's huge document on the requirements for reaching eligibility for training and for participants to be engaged in critical thinking.

#### Considerations

- 1. Encourage eligibility for basic training
- 2. Time consuming task of informing people of eligibility How to capture information, could this be on EMDR Website?
- 3. Need to take load off Tom Flewett and Astrid Katzur
- 4. Longer term risk pre apprenticeship model; group to meet with Tom and Astrid and consider 'what does content need to look like, risk issues, fidelity to training protocol'

**Action:** Kay, Diane and Nici to meet. Diane not to liaise with Tom and Astrid at this stage Website to expand on eligibility criteria.

Astrid updated Board from 2022 she will be the only trainer in New Zealand as Tom Flewett will retire. Discussion on the need to train more trainers, what will training schedule look like, how to support Astrid.

- **5. Research group.** Not meet. **Action**: Glenda to send out invite.
- 6. **Recommendation request.** Astrid has received a request from EMDR Spain for EMDRNZ to consider writing a recommendation on Dolores Mosquera following her presentation. Passed. **Action:** Astrid to write to EMDR Spain.
- **7. Child training.** 28 people attended. Trainers available for 2022 if required. Ariane to send a list of participants to Astrid for subsidy rebate. **Action:** Kay and Indra to develop an invoice for members. Indra to email on EMDR Members on participants list.
- 8. RTEP/GTEP. Astrid ran another group two weeks ago and interest has been raised in having a RTEP/GTEP Interest Group as a network for those trained and to run groups together. Action: Astrid to speak with Sally and Indra about possibility of having names on website under

'Members Only' area. If this is possible Astrid to ask all participants if they would like their names on the list. Proposed Astrid, seconded Glenda

**9. Grow.** Astrid updated - she to spoken with Shaun Lines from GROW. Astrid to explain EMDRNZ Association expectations, what we do and why, that we were Institute trained and there were non Institute trained people who would need to redo their training with Institute trainers. Shaun offered for Jenny to work with Astrid. Astrid had conversation with Jenny whose trainings will not fit NZ criteria, Jenny is not looking for work and she has not applied for accreditation under EMDRNZ.
